AIIMS Bhopal is a premier Institute of National Importance (INI) established by the Ministry of Health & Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojna (PMSSY) with the aim of correcting regional imbalances in quality tertiary level healthcare in the country and attaining self-sufficiency in graduate and postgraduate medical education and training.

2. The Executive Director, AIIMS Bhopal invites applications in the prescribed proforma from Indian Nationals/ persons registered as Overseas Citizen of India (OCI) cardholder under Section 7A of the Citizenship Act, 1955 for the following faculty posts in the Department of Physical Medicine & Rehabilitation on Direct Recruitment basis:-

**3. Important Note:-**

- (i) The above vacancies are provisional and subject to variation at any time. The Executive Director, AIIMS Bhopal reserves the right to vary the vacancies including reserved vacancies, as per the Govt. of India rules/circulars and requirements.
- (ii) Reservation is applied as per the roster guidelines provided by the Ministry of Health & Family Welfare, Government of India and as per Government of India Rules.
- (iii) Age, experience and all other prescribed qualifications will be counted as on the date of publication of the advertisement in the Employment News.
- (iv) The period of experience wherever prescribed shall be counted after obtaining the prescribed qualification.

- (v) Relaxation of Experience for SCs/STs/OBC in Direct Recruitment, if any, may be considered by Competent Authority as per Government of India guidelines in the matters.
- (vi) Experience may be relaxed in highly deserving candidates at the discretion of the Selection Committee.

**I. ESSENTIAL QUALIFICATIONS AND EXPERIENCE:**

(a) Professor- Essential for Medical candidates:-

1. A medical qualification included in the I or II schedule or part II of the third schedule to the Indian medical council Act of 1956 (Persons possessing qualifications included in part II of third schedule should also fulfill the condition specified in section 13(3) of the Act.)
2. A postgraduate qualification e.g. MD/MS or a recognized qualification equivalent thereto in the respective discipline/subject.

Experience:- Fourteen years teaching and/or research experience in a recognized institution in the subject of specialty after obtaining the qualifying degree of M.D./M.S. or qualification recognized equivalent thereto.

(b) Associate Professor - Essential for Medical candidates :-

1. Same as 1 & 2 for Professor

Experience:- Six years teaching and/or research experience in experience in a recognized institution in the subject of specialty after obtaining the qualifying degree of M.D./M.S. or a qualification recognized equivalent thereto.

(c) Assistant Professor- Essential for Medical candidates

1. Same as 1 & 2 for Professor

Experience:- Three years teaching and/or research experience in experience in a recognized institution in the subject of specialty after obtaining the qualifying degree of M.D./M.S. or a qualification recognized equivalent thereto.

**I. APPLICATION PROCESS:**

- Applications are invited from Indian Nationals and OCI in the prescribed form only through by speed post/Registered Post.
- **Candidates who wish to apply for more than one post should apply separately for each post and pay the application fee for each post.**

**II. APPLICATION FEE:**

- The application fee for General/OBC/EWS category is Rs. 2,000/-.
- For SC/ST/PwBD and Women candidates are exempted from payment of Application fee.
- Fee should be paid through Demand Draft drawn in favour of Executive Director, AIIMS, Bhopal payable at Bhopal.
- Fee once remitted will not be refunded.

### III. LAST DATE OF APPLICATION:

- The duly filled application in the prescribed proforma, along with self attested copies of certificates and application fee should reach the Deputy Director (Admin.), All India Institute of Medical Sciences, 1st Floor, Sardar Vallabh Bhai Patel Bhawan, Saket Nagar, Bhopal-462020 within 30 days of publication of the advertisement in the Employment News for the current Rolling Cycle, however, applications received beyond the stipulated date may be considered in subsequent cycle(s) and notified on the website of the Institute subject to availability of vacancies.
- The envelope containing the application should be super-scribed with "Application for the post of \_\_\_\_\_ Department of PMR on direct recruitment basis.

### IV. FROM OTHER INSTITUTES:

Those who are working in Central/State Government/Semi Government / Autonomous body have to submit "**No Objection Certificate**" from their respective organization or apply through proper channel.

### V. AGE LIMIT & AGE RELAXATION:

1. Age limit refers to completed age in years as on last date of submission of application.
2. Upper Age Limit: **Professor:** - Not exceeding 58 (Fifty-eight) years as on closing date.  
**Associate Professor/ Assistant Professor:** - Not exceeding 50 (Fifty) years as on closing date.
  - (i) Upper age limit shall be determined as on the date of publication of the advertisement in the Employment News.
  - (ii) (ii) No age relaxation would be available to SC/ST/OBC/PwBD/EWS Candidates applying for unreserved vacancies.
  - (i) Age relaxation is permissible to various categories as per prevailing Government of India Rules

### VI. RESERVATION:

1. OBC Candidates will attach certificate, **in the prescribed format as per Gol norms**, from the prescribed authority for Central Government posts along with certificate that the candidate does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year of closing date of advertisement.
2. For SC/ST Candidates - Certificate should be issued by Tehsildar or above rank officer in format of State/Central Government.
3. Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/ PwBD/EWS will be considered subject to Caste Certificate issued by the appropriate/ competent authority on the prescribed format. Community should be clearly and legibly mentioned in the certificate. OBC candidate's eligibility will be based on the caste(s) borne in the Central List of Government of India. OBC candidate(s) should not belongs to Creamy Layer and their sub-caste should be matchwith the entries in Central List of OBC, failing which their candidates will not be considered undeany of the applied reserved category post(s).

### VII. SCRUTINY OF APPLICATIONS:

1. Based on the information as filled in the Application form, the candidates may be short- listed for interview. The candidates should bring no objection certificate from the current employer and produce all relevant documents in original in support of details furnished in their application at the time of interview.
2. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate to be called for interview or for selection. Based on bio-data, the Screening Committee may short-list candidates for interview. Candidates called for interview will have to produce all relevant original documents in proof of details furnished in their application at the time of interview. They may also be asked to submit an affidavit/declaration as decided by the Competent Authority at time of Interview. The methodology of Selection will be decided by the Selection Committee as deemed fit besides any other matter relating to the Selection process.

#### **VIII. SITE OF INTERVIEW:**

The interview will be held at AIIMS Bhopal or any other places as per decision taken by the Standing Selection Committee. No TA/DA will be paid for appearing in the interview.

2. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of Interview or apply through proper channel.
3. Self-Attested photocopies of Degrees, Certificates, Mark sheets, Age proof, Caste Certificates etc. must be attached and annexed with the application form and the same shall be produced in original along with photocopy for verification at the time of interview.
4. List of eligible candidates, Eligibility of the candidate and any further information related to this advertisement, date and time for interview etc. shall be notified only on the website of the Institute.
