Experience: The period of experience rendered by a candidate on part time basis, daily wages, visiting/ guest faculty will not be counted while calculating the valid experience for short listing the candidates for test. Only those experiences which are relevant and acquired after the passing date of the qualifying qualification will be considered.
6. The selection will be based on academic performance, research experience and performance during the interview. The selected candidates will be required to produce all the original documents and medical & character certificate at the time of joining.
7. No Objection Certificate from the present employer is must, if the candidate is already working.
8. The selected candidate will be working on whole time basis and will not be allowed to register himself/herself for any academic programme except Ph.D. for JRF/SRF. The place of work will be ICAR-IISR, Indore. However you can engage out of station at any time, subject to requirement of the project/scheme.
