All the championships mentioned above should be conducted under the aegis of recognized International/National/State Sports Federations and recognized by the Railway Sports Promotion Board.

Note- For recruitment in Pay Matrix Level 1 (7th CPC), achievements should be in the current and/or immediate **preceding 02 years i.e .from 01.04.21** and the sportsperson should be an active player. For validity of sports achievement, concluding day of the championship/event shall be taken into account.

IV (a) APPLICATION FEE:-

(i)	For all candidates except those mentioned in sub-Para (ii) below	Rs. 500/-- (Rs. Five Hundred Only)
(ii)	For candidates belonging to SC/ST /Ex-Servicemen/PersonswithDisability/Women/ Minorities* and Economic Backward Class**	Rs. 250/- (Rs. Two Hundred Fifty Only) with a provision for refunding the same to those who are found eligible as per notification and actually appear in the Selection Trials. Candidates in this category should check their eligibility thoroughly before applying. Fee in respect of candidates who are ineligible, but still apply shall not be refunded.

NOTE:-Candidates are advised to deposit the requisite Fees for application in favour of **PFA/RCF/KXH's Online Account No. 65035290377, IFSC Code SBIN0050540 of State Bank of India** before the closing date and **copy of the fees receipt should be attached with application otherwise application will be rejected. Cheque, Draft & Postal Order will not be accepted and hence will be rejected.**

(b) FEE EXEMPTIONS:-

- A) For claiming exemption/refund from the application fee, Minority candidates should submit 'self declaration' as mentioned in Format 'A' at the time of Document Verification. ***Minorities mean Muslims, Christians, Sikhs, Buddhists and Zoroastrians (Parsis).** Such candidates claiming exemption of application fee will be required to furnish minority community declaration' affidavit on non-judicial stamp paper that he/she belongs to any of the above minority community. If the affidavit is not produced during document verification, the candidature will be rejected.
- B) **** Economically Backward Classes (EBC)** will mean the candidates whose Family Income is less than Rs. 50,000/- per Annum.

The following authorities are authorized to issue income certificate for the purpose of identifying Economically Backward Classes (EBC):

- (i) District Magistrate or any other Revenue Officer up to the level of Tehsildar.
- (ii) Sitting Member of Parliament of Lok Sabha for persons of their own constituency.
- (iii) BPL card or any other certificate issued by the Central Government under a recognized poverty alleviation programme or Izzat MST issued by Railways.
- (iv) Union Minister may also recommend for any persons from anywhere in the country.
- (v) Sitting Members of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside.

V). The mode of recruitment will be as follows:-


The eligible candidates will be informed by post for trial. Recruitment will be done on the basis of Trial. The candidates declared fit by Trial Committee will be considered for next stage i.e. Interview stage.

VI) How to apply:-

1. Application in prescribed format on A-4 size good quality paper may be down loaded from he website www.rcf.indianrailways.gov.in may be typed neat & clean one side.
2. Application is to be filled up by the candidates himself in his/her own handwriting and must signed affixing a passport size photograph with clear face on the space provided and one should be attached duly attested. Candidates should apply his/her application only once. (If two applications of same candidate will be received, his/her application will be rejected).
3. Applicant will attach the attested photocopies of Educational and Sports achievements certificates. SC/ST/OBC/EWS candidates should also attach the attested copy of caste certificate on proper format.
4. **Candidates to ensure their eligibility before applying:-** The candidates should ensure that they fulfill all eligibility conditions prescribed for the post. Eligibility of the candidates for the post notified in this notification would be decided on the basis of the information furnished by them. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria for the post(s), his/her candidature will be cancelled forthwith.
5. Railway Administration will not be responsible for late delivery and postal delay.
6. The last date & time for receipt of application in the office of the General Manager (Personnel) Recruitment Cell, Rail Coach Factory, Kapurthala-144 602 is dated **19.02.2024 up to 17.00 hrs.**
7. Candidate superscribe clearly on the Envelope **"RECRUITMENT AGAINST SPORTS QUOTA FOR THE YEAR 2023-24 IN LEVEL-1.**

8. The application can be sent by any type of post.
9. Railway Administration reserve the right to cancel the Recruitment process in exceptional circumstances.
10. Under no circumstances applications received after the closing date & time will be entertained.
11. The sportspersons appointed against Sports Quota through Open Advertisement will undergo probation periods of two years after completion of training, if any.
12. The sportspersons recruited against Sports Quota through Open Advertisement will have to fill and sign the Service Bond for a period of five years.
13. The sportspersons appointed through Open Advertisement Quota, shall fulfill the minimum medical norms for the post, for which they will be appointed.
14. Sportspersons recruited against sports quota through open advertisement shall be terminated from service, if the information and documents furnished by them for recruitment, are found incorrect/fake at any stage; observing requisite procedure for such termination.
15. Applicant should mention his/her playing position alongwith the game in the application form.
16. Candidates those who are already in service of PSU/Govt Organizations and are eligible for the above should produce 'No Objection Certificate' for the same from their employer at the time of applying /trials.
17. Candidate's admission at all stages of the recruitment will be purely Provisional subject to satisfying the prescribed eligibility conditions. Mere issue of call letters to the candidate will not imply that his his/her candidature has been finally cleared.
18. Sportspersons having sports norms for higher level and apply against the vacancies for the lower level, can be considered. However, he/she will not claim for higher level after joining the Railways on the basis of sports achievements prior to joining Railways.
19. The decision of selection committee/administration in all matters relating to eligibility, acceptance or rejection of application etc. will be final and binding on the candidates and no inquiry or correspondence will be entertained in this connection.
20. Production of original documents of Date of birth, Educational Qualification, Sports Achievement and SC/ST/OBC/EWS etc on the day of Trial and Interview is mandatory without which they will not be allowed to appear in the Trial/Interview. Certificates in languages other than English or Hindi should be accompanied by an attested translation in English/Hindi. No TA/DA/Accommodation will be given for appearing in the selection trials/interview. Applicants will have to bring their own kit. They may also be required to stay during the selection trials for 2-3 days, for which they have to make their own arrangements. The railway administration has all rights reserved to fix any date/place or postpone trials/interview or cancel due to unforeseen causes against which no claim will be accepted.
