1. Contractual Senior Resident under Central Residency Scheme for Three years subject to renewal / extension every year on satisfactory performance. (Total post-26, bifurcated as- (UR-12, EWS-02, OBC-06, SC-04 & ST-02)
2. Full time/Part Time Specialist on Contractual basis for Three years subject to renewal / extension every year on satisfactory performance or till Regular Specialist joins-whichever is early. (Total post-16, bifurcated as- (UR-05, EWS-02, OBC-06, SC-01, ST-02).

For Casualty (Accidents & Emergency Dept.) preference will be given to Postgraduate having PG in Critical care.

3. How to apply: -

- i. The eligible and desirous doctors fulfilling the educational qualifications/eligibility conditions should submit their applications(as per Annexure-‘A’) along with one set of self-attested copies of relevant documents in support of age, qualifications, attempt certificate, Mark-sheet, Degree, MCI or State Registration(s), EWS/SC/ST/OBC/PWD/Ex-serviceman certificate & experience certificate etc. and 2(two) recent passport size photographs.
- ii. The candidate who is currently in the employment must bring experience certificate (working certificate) and No Objection certificate (NOC) from the present employer, failing which his/her candidature will be liable to rejection.
- iii. Aspirants possessing relevant qualification along with registration as on the date of interview will only be considered; those whose result is awaited will not be considered.

4. Terms & Conditions: -

1. Candidate should report in the Administration Office situated at Ground Floor of ESIC Hospital, Sonagiri, Bhopal from 9:15 A.M to 11:00 A.M on the stipulated date along with the relevant copies of their documents.**Candidates reporting after 11.15 A.M. will not be entertained for Walk-In-Interview.**
2. Reservations for other reserved categories will be executed as per existing Central Government Rules.
3. Candidates seeking Reservation / Age relaxation benefits under SC/ST/OBC/EWS/PWD/Ex-serviceman category must ensure that they are entitled to such reservation as per eligibility prescribed in the notice and as per the instruction issued by Government of India. They should also be in possession of the certificates in the prescribed format of Govt. of India in support of their claim. Candidates seeking reservation under EWS category, should submit their EWS certificate as prescribed vide Govt. of India, Department of Personnel & Training OM No. 36039/1/2019-Estt. (Res) dated 31-01-2019. Candidates claiming reservation/age relaxation under OBC category should submit their OBC certificate as prescribed vide Govt. of India, Department of Personnel & Training OM No. 36012/22/93- Estt.(SCT) dated 08/09/1993 which is modified vide OM No. 36033/3/2004 Estt. (Res.) dated 09/03/2004, further modified vide OM No. 36033/3/2004 Estt. (Res.) dated 14/10/2008 or the latest notification of Government of India.
4. Private practice of any kind will not be allowed (except for Part Time Specialist)
5. The number of vacancies/ category-wise vacancies may vary/likely to increase or decrease.
6. No TA/DA will be paid to candidates for appearing in the walk-in-interview.
7. Application should be submitted for each post separately.
8. The Medical Superintendent reserves the right to alter the date or cancel the interview.
9. Full-time Specialist on contractual basis shall be recruited for a period of 3 years with annual evaluation and term renewed every year based on satisfactory performance.
10. Selected candidate has to sign the contract agreement containing terms and conditions, on a Non-Judicial Stamp Paper of Rs. 500/- before joining. The original contract will be with the hospital and its copy will be with candidate. The cost of the Non-Judicial Stamp Paper will be borne by the candidate.

11. The Contractual specialist shall be responsible for all cases undergoing treatment under his supervision in his discipline.
12. Full time Contractual Specialists will be entitled for the leave @ 04 days for each month of work on prorated basis in a calendar year. In the event, the specialist prefers not to avail the leave, the same may be encashed to a maximum limit of 30 days/ year.
13. Period of contract for part time contractual specialist will be of 1 year from the date of joining or till regular incumbent joins.
14. Part time contractual specialist will not be entitled for any kind of leave.
15. The selected Candidate must have a professional indemnity policy which should cover the period as desired by ESIC in the bid. The policy is meant to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional services. The minimum sum assured per annum should be Rs. 30 lakhs for Anesthesiologist, Rs. 20 lakhs for the General Surgeons, ENT, EYE, Orthopedics, OBGY, etc. and 10 lakhs for the General Medicine, Dentists, Radiologists, Pathologists etc. A copy of the Insurance & Premium and receipt must be submitted within 7 days from the date of engagement.
16. The Contractual Specialist and Senior Residents (to be engaged on Contract) will be required to deposit security of Rs. 10000/- (Rupees Ten Thousand only) through Demand Draft in favor of ESI Fund A/c. No.1, Bhopal at the time of joining. The same is refundable after completion of contract period and on production of "No dues certificate".
17. It is advised to candidates to bring original documents & Xerox in support of DOB, Educational qualifications, experience, caste certificate, EWS certificate etc.
18. Candidates applying for senior residents have to give an undertaking regarding Government hospital residency compliance. Candidates who have already worked as SR for 03 years after PG Degree/Diploma under Central Residency scheme in any Govt. organization are not eligible to apply for the post of Senior residents on contract basis under 3-year Senior Residency scheme.
19. If at any stage of recruitment process, it is found that the candidate is not fulfilling any of the eligibility condition ESIC reserves the right to reject/ cancel the candidature/selection/ appointment of said candidate.
20. Selected candidates will have no claim for regularization of services in the Hospital/Medical Institution.
21. The appointment is subject to Medical Fitness.
22. The selected Full Time/Part Time Contractual Specialist will be required to submit acceptance/consent letter in writing before appearing for Medical examination.
23. Preference will be given to Full time Specialist. In case of unavailability of Full time Specialist part time specialist of the respective category will be appointed.
24. Contractual engagement may be terminated /discontinued by the either side giving one-month prior notice to this effect without assigning reason.

Note: - The vacancies have been prepared after all due diligence & care after implementation of Government of India reservation roster as per rules. If any discrepancy is noted at later stage, then it may be corrected/ rectified at the time of notice.

Other Instructions: -

1. All the interested candidates are requested to appear for the document verification within the schedule time (9:15 AM to 11:00 AM). No candidate will be allowed to attend document verification after 11:15 AM on all schedule date as mentioned above.
2. Only the candidates whose documents are verified and found eligible for the post of Senior Residents & Full time/part time Contractual Specialists will be allowed to attend walk-interview.
3. The Medical Superintendent, ESIC Hospital, Sonagiri, Bhopal reserves the right to vary these vacancies including increase or decrease or cancellation of filling up of any or all post without assigning any reason.
4. Change in date of interview, etc if any, will be intimated on website (www.esic.gov.in) only. Candidates are advised to check the website regularly for any update/information relating to the recruitment. Other terms and conditions as mentioned above.
